HIP served 49,157 meals to homeless, low-income and no-income individuals and families in the community. This is a 41% increase over FY2013-14 and included 6,485 summer lunches for children 18 and under, 34,896 meals through our Healthy HIP Packs program and 3,584 meals through our Senior Meal Program. The Healthy HIP Packs Program provides weekend food for students at risk of hunger when out of school.
HIP also provided 20 cooking demonstrations at the local food bank, giving away 1,115 samples and 611 recipe cards highlighting healthy ways to cook products distributed by the food bank.
These programs are all delivered in partnership with local schools, community organizations, food banks, food distributors and local businesses.
