**Nutritious Meals: During 2022/23, HIP served 154,747 meals to Seniors, Children, and individuals experiencing homelessness. 27,751 meals were served to seniors, most delivered directly to participants' homes. HIP delivered 68,119 Healthy HIP Pack weekend meals to students in partnership with local schools, provided 11,744 weekday meals to students & parents when Seattle & Shoreline schools were closed for Summer break, and 45,832 meals to people experiencing homelessness.**

**Education: During 2022/23, HIP ran two cooking/nutrition education class series for school children and families, a gardening class for youth, and two food justice workshops for high school students. HIP also ran many cooking & nutrition activities as part of its Summer Meals.**
